All twenty (20) companies have provided the required mandatory documents and were found to be responsive.

The lowest bidder Sims Technologies did not quote for ten (10) MacBook, the second bidder (BLHZBOX Investment cc) did not include the product specifications (MacBook) and the third bidder (Bridge Media and Information Services cc) quoted for quoted for 512GB SSD instead of 1 TB SSD that was requested.

#### Recommendations

The Committee then recommend the fourth responsive bidder **Messers Smart Guard Solutions cc** to supply Macbook, laptops and other IT equipment to the amount of Seven Hundred thirty four Thousand, Seven Hundred Thirty Four and Eight Five cent **N\$ 734 734.85**.
